## **Fabric & Fiber of Scotland Competition Rules**

1. Entries must be submitted by the garment/accessory creator but may be modeled by someone you choose.
2. Garments and accessories must be made of 100% Scottish-origin wool. Lining, interfacing and trim may be from other textile sources.
3. Entries must be the entrant's own work.
4. Competitors may enter more than one item/garment. Please use a separate entry form for each.
5. Garments/accessories will be modeled on stage on competition day.
6. Judging decisions are final
7. No refunds will be given for entries received.
8. Competitors will be assigned a number and will model garments in number order.
6. **Closing date for entries is May 20, 2026. Entry forms must be received by this date.**
7. Competitors must remain in their constructed garment for awards presentation.
8. It is the responsibility of competitors to pick up prizes at the competition. Unclaimed prizes will be forfeited after June 30, 2026.
