Competition Rules

1. Events in solo piping, solo drumming and pipe bands are conducted under the rules of the BC Pipers' Association. The rules are available at the BC Pipers' Association website: www.bcpipers.org
2. Competitors are required to be attired in acceptable Highland dress.
3. Pipers and drummers will tune in designated areas only.
4. Judges' decisions are final.
5. No refunds will be given for entries received.
6. Closing date for entries is: May 10, 2022. Entries must be **received** by this date.
7. Complaints must be written, signed and submitted by the end of the competition, accompanied by a \$25 (U.S.) fee. Refundable if sustained.
8. It is the responsibility of competitors to pick up prizes at the competition. Unclaimed prizes will be forfeited after June 30, 2022.
9. Competitor numbers will be available at the admission gate. Band competitors will gain admission by appearing on the band's player roster officially registered with the BCPA Membership Chair (membership@bcpipers.org) as of May 21, 2022.
10. All bands are required to perform in the Closing Massed Bands to be eligible for prize money.
11. Where tune submissions are required, they must be included with entry (Open, Snare Drumming and Bands). Tunes must be entered online or submitted with copy of entry by May 10, 2022.
12. Solo competitors and bands who are not current members of the BC Pipers' Association (BCPA) or an officially recognized piping/pipe band association affiliated with the BCPA (associations in the Alliance of North American Pipe Band Associations), must pay an additional \$10.00 per solo competitor or \$50 per Band and include the fees with entry.
